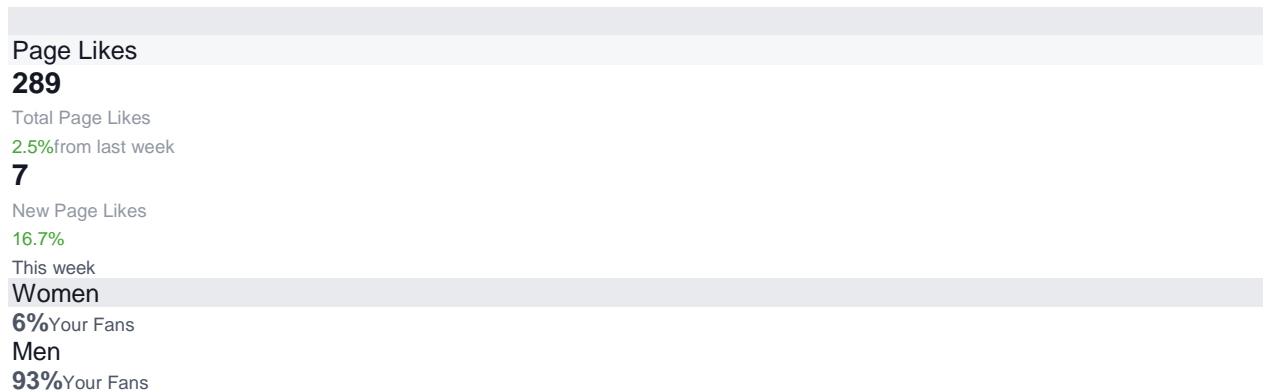

ATJA vs USJA

Discussion of USJA current and future operation and how to capitalize on the situation and capture disenfranchised USJA members.

ATJA needs Class A status; being attempted by Peter Contardo currently.

This would mean validation of the ATJA and consistency with USA judo, USJF, USJA, etc.

This allows sanctioning of events with multiple JA organizations and support of ATJA members to compete or train in other accepted organizational environments.

ATJA has Insurance that is class A equivalent.

ATJA needs to officially adopt a Safe Kids for coaches program to help with the class A status.

Attract new members with inexpensive validations of rank. These are the same as the current testing fees.

Ie. The sum of, 2 years at junior membership price, plus 3 years at adult membership price, with the 10% discount on that sum.
